INTRODUCTION

TeachVac and TeachVac Global operate as a job matching service for education jobs in England (TeachVac)

and the Rest of the World (TeachVac Global). Jobs in schools are highlighted to registered applicants who

decide whether to contact a school about a job and if so make that contact personally. Oxford Teacher

Services (TeachVac, TeachVac Global, TeachSted) do not pass on ANY personal data to schools or other third

parties.

Oxford Teacher Services Ltd acts as the 'Data Controller' for the personal information that we collect from

users of our websites and web-based systems.

We do not pass on your information to other parties nor do we store it to contact you for a purpose other

than under the direction of the Data Controller. We employ a high standard of security and have implemented

technical and organisational measures to ensure your personal information is processed securely.

The information we collect is stored safely and securely. All information is stored in the UK. UK2 provide our

server infrastructure and will have access to the information we collect. However, their use is limited to that

required to ensure our systems are operational.

INFORMATION WE COLLECT FROM YOU AND WHAT WE DO WITH IT

We collect very little information – just that required to provide the education job matching service. Since the

service is 'closed' you are required to log in to access it.

Username / password

This is only used to allow you access to the service. You, as a user, choose the User name and password. The

password is encrypted and no one at Oxford Teacher Services is able to see the unencrypted password. In the

event of forgetting a password, a new one is generated.

Email address

The email address is used only to alert you to job opportunities and very occasionally for system status changes

or announcements that affect the operation of the service. It is not passed on to any third party save as is

required by law.

Other data

Some other data is stored to provide the matching service. Typically this includes only an indication of the level of

post required in any new job and the geographic area for new jobs. We do not either ask for or store current

location or employment level.

Our lawful basis for collecting and holding this information is our fulfilment of an agreement ("contract") to

provide access to a site which would not otherwise be accessible to you and to provide the primary service for

that site (i.e. education job matching).

Where we offer a paid service - this is for organisations, not individuals - payment processing is entirely handled

by a third party. Oxford Teacher Services only records the success or otherwise of the transaction in order to

supply the service.

Where an individual explicitly makes a request of Oxford Teacher Services for a service or supply of goods than

that request and the information relating to that request will be collected and stored. Any personal information

will not be passed on to third parties save for the details required to process a financial transaction (see

preceding paragraph).

Where a user is granted access to a system, the registration information will be kept for as long you require

access to the site. You can access or amend the information that we hold about you in our web-based systems via

your 'My Details' page.

INFORMATION WE COLLECT FROM ALL SITE USERS AND WHAT WE DO WITH IT

All of our websites and web-based systems automatically collect some information which may be considered

'personal information'.

Our web servers collect some data (e.g. IP address and browser type) which we use to identify the country of

origin of the request for statistical purposes and to enhance the browser experience to suit the majority of users.

We will not make any attempt to identify individual users, except where there is a reasonable suspicion that

unauthorised access to systems is being attempted. Aggregated analysis of this anonymised data is used to

monitor usage of the website or web-based system. Statistical analysis of anonymised data may be passed on to

third parties (e.g. the number of teachers currently looking for a maths job in England).

TeachVac and TeachVac Global are registered with Google Analytics to provide statistical data about search

results.

Oxford Teacher Services only receives anonymised statistical data from these cookies. Oxford Teacher Services

only make use of 'Necessary Cookies' on our web sites. These are cookies which are required for the operation

of the site – e.g. to navigate you from one page to another. We do not store these cookies permanently (we use

'Session' cookies only) or make use of them to track previous visits. These Cookies are not shared with any third

parties.

Unless a longer retention period is required or permitted by law, we will only hold your personal information on

our systems for the period necessary to fulfil our purposes for processing.
